Joe Bloggs Special School is based in West Sussex and is for students aged between 11-18 years old. Our school caters for students with severe learning difficulties or profound and multiple learning difficulties. Many students have additional

complex needs including ASD, epilepsy, physical or sensory impairments and some have additional medical needs. All students have an EHCP. We support our students to achieve meaningful qualifications and would like to add Arts Award to our remit, as the arts are a very important part of our curriculum. We have a strong arts department, with opportunities in drama, music and visual arts. We focus on enabling our students to develop the necessary personal, social and independence skills so they can achieve their goals and ambitions - to ensure they are well prepared for adult life. There are 3 staff at our school trained to deliver Discover & Explore, working across various arts-based disciplines; giving our students lots of choice. Our SLT are very supportive of Arts Award but would like to see how successful this pilot is before they commit to putting funding in place to continue running Arts Award in the future.

These young people have diagnoses ranging from autism, Downs Syndrome, ADHD, epilepsy, weak motor control, hearing and sight impairments and various learning difficulties. Many of them require support in personal care and medications to be administered. 5 of the young people are BAME. They can often have challenging behaviour and need safe, quiet spaces to go to. Some also require assistive technology to support them in communication and producing work. They are a creative, bright group who are eager to learn and

staff want them to reach their full potential. We want them to have their amazing work in the arts recognised with a qualification.

About your project

Over the spring term, these pupils will work towards achieving their Explore Arts Award. Arts Award will be embedded in the arts curriculum so they will be working on their Arts Award during class time. The pupils will be able to choose which arts discipline they want to do their Arts Award in; music, drama or visual arts. The young people will use a mixture of sketch books, proformas (that we've put together ourselves), annotated photos, video, audio and some witness statements and scribing. Some students might use signs and symbols too or creative responses to their experiences. We will save all evidence in Google Drive, with a folder for each young person and within that, a folder for each part of Explore. We will take photos of hard copy evidence.

Part A:

We would like to invite a number of local professional artists into our school to provide a workshop for our students, so they can experience something they've never done before. In music, this will be a percussion workshop. In drama they will be able to take part in a miming workshop and in the visual arts, we will have a graffiti artist coming in to do a workshop where they will create a mural with the young people.

Part B:

The students will explore the work of the artist delivering the workshop they attend for part A. We will do a group activity with them where they can ask the artists questions about their work as an artist. We would like to take the students to see an autism-friendly performance of a show at the local theatre. This includes a free backstage tour and Q&A session with some of the actors and theatre staff, so that the students can find out directly from the staff about the work of a theatre. We will use the school mini buses to travel to the theatre venue, which is the safest way for our students to travel.

Part C:

Back in class, the students will create a final piece of art work in an art form of their choice. This can relate to the workshop they took part in for part A, or it can be something else entirely.

Part D:

We would like to have a celebration event at the end of the project where we invite parents along. In class, we will help the students reflect on what they did for parts A-C and identify something they enjoyed/achieved. They will share this with their peers or a family member at the celebration event.

This project is a pilot for delivering Arts Award at our school for the first time. We have a strong arts department at our school and the students do lots of arts related work, but don't currently receive formal recognition for it. This is why we want to offer them an opportunity to achieve an Arts Award and the opportunity to experience an arts activity that we aren't able to provide within school ourselves - something a bit different. We also want to be able to support our local community of artists by inviting them into our school to work with our students. We are also very keen for our students to experience a live autism-friendly performance at a local theatre too as many of them have never had this opportunity. If this project is successful, our SLT have already said they will put aside some of the school budget to fund similar projects in the future where we work in partnership with local artists and arts venues. We also plan to explore organising other internal funding opportunities and events such as bake sales, art and craft sales, exhibitions, guizzes, fetes and sponsored activities to fund our Arts Award offer. In terms of evaluation, we will gather feedback from the students as we deliver the project and will organize an evaluation session with them after the project. We will also send out a feedback survey to parents/carers. All the feedback we gather will inform the direction of future Arts Award projects at the school.

- Fee to enter young people for Explore this is so the young people can achieve their Arts Award and receive a certificate.
- Part A Music: percussion workshop we don't have many percussive musical instruments at our school, which is why we want to offer this as a music option for our students.
- Part A Drama: miming workshop the artist providing this workshop specialises in working with SEND young people, so we are really excited to hopefully have them work with us on a technique that will be new to most of our students.
- Part A Visual arts: Graffiti artist/mural: we haven't done graffiti art in school before so this will be a new opportunity for the students with the added bonus of working on a mural to display in the school grounds.
- Part B Tickets to visit our local theatre to see an autism-friendly show: many of our students have not had the opportunity to experience live theatre, mainly because many shows are not SEND friendly. There is also the added bonus of a free backstage tour & Q&A, which will enrich the experience for our students.
- Art materials for part C: we anticipate needing to buy a few specialist materials for students to create their piece of art work, but this depends on what they want to do for this part.
- Part D Refreshments for celebration event: we have put a small amount of the school budget aside to provide refreshments for parents/guests coming to the event
